Pete never did, he would just, by borrowing money from the guys around him, until maybe doing a baseball card show or what not, or maybe until he had won a little back the following week he could postpone paying a bookie, postpone going to Reuven and maybe coming up with some cash money on his own. That's how...I mean does that make...does that you know, I don't want to be discussing, there are so many things that I don't be sitting here talking to you and not be making all the pieces fall into place.

DOWD: You can only do the best, you are doing fine.

MARCUM: Pete's wife had told me that when her and I had talked before that they gave them so much of an allowance that they deposit into their account.

DOWD: Who is they?

MARCUM: I guess maybe Reuven, their bookkeeper. And, they gave them a certain allowance each week and then Pete and Carole wrote their own checks off of that. All the bills and everything were sent straight to Reuven, all of Carole's charge cards, stuff like that was sent straight, and then Carole had said that

Reuven had told Pete that if Carole didn't stop charging and they had to really watch what they were spending the money on, then like in two or three years they would be broke. But, if they would stay on this budget type thing they had them on, that Pete would not have any problems from there on.

DOWD:

Danita, do you recollect any other contacts with Pete or information about Pete that we have not discussed or that Paul hasn't talked about that you might have had separately?

MARCUM:

Uhm. I do remember like three or four times going over to Pete myself and talking to Pete about Paul's money,

DOWD:

OK.

MARCUM:

And it was a dead end street. You know, I mentioned to him that we had bills due and Pete would just say, you know, Danita what do you want me to do, he's like, you know, I won from one and lost from the other, I feel like I'm even I don't think I owe Paulie anything.

DOWD: Do you remember when these conversations were, Danita?

MARCUM: They stemmed, I'm not 100 percent sure, but I think some of them stemmed before the FBI came to see Paul, and then they stemmed afterwards because there was two or three times afterwards that I talked to Pete about it. And, he wouldn't come up with any money.

DOWD: You also had occasion, from what you said yesterday, to place bets with Pete.

MARCUM: Yes, I did.

DOWD: On how many occasions did that occur?

MARCUM: I'd say maybe through the whole time, maybe ten times, if Paul wasn't around.

DOWD: Would that be a call by Pete?

MARCUM: A couple of times, yes, Pete would always call me,
Paul would tell me that Pete was going to call like
at, you know, a certain specific time, be there. So
when Pete would call me I would say yeah, who do you
want, then Pete would give me the numbers, first he

would tell me the teams, but we changed over to cards, he would give me the numbers. After he gave me the numbers I would repeat the numbers back to him to make sure that I didn't mess it up. Then I would call the bookie, I would give the bookie the names, and then as I was giving him the names he would tell me the lines. The only way that I would call Pete back is if Pete wanted to know a specific line on a specific team.

DOWD: Do you recall what sports?

MARCUM: Baseball, baseball was the only thing that I took.

DOWD: And I'll ask you, I think I asked you, but I'll ask you again, on any one of these ten occasions did you place bets on the Cincinnati Reds for Pete Rose.

MARCUM: Yes.

DOWD: Do you recall whether it was more than once or was it on all ten occasions?

MARCUM: Like, well, Paul had told you that the one time...I don't know, I'm not going to say yes for sure, but

the one time I asked Pete don't you want, I thought I did, I asked him don't you want "1", which meant Cincinnati and he said, no I'm not taking anything there. But, every, I mean 99% of the time whenever I talked to him he did take the Cincinnati Reds.

DOWD: So, he would give you a number which was a code for a team?

MARCUM: Right, I made two index cards myself and I numbered them. First would be first would be your national league teams and then straight down the list all the teams and then I gave Pete the same identical card.

DOWD: Do you still have the cards?

JANSZEN: But, he made the cards himself.

MARCUM: Yes, Pete made them and then I made up a separate one....

DOWD: These are 3x5 index cards.

JANSZEN: I think we are getting confused here. I think you made some cards, but I think Pete went ahead and made cards himself.

MARCUM: Right.

JANSZEN: Because the cards that we have were in Pete's handwriting at the time, it wasn't your handwriting.

MARCUM: Right.

DOWD: Do you still have those cards?

????

DOWD: Do you recognize Pete Rose's handwriting?

MARCUM: Yes.

DOWD: How do you recognize it?

MARCUM: Um, I recognize it from seeing Pete's sheets like if
we were sitting around and Pete would open his book.
I recognize his signature only because dealings,
because he signs Paul bats and clothes for him.

DOWD:

If I showed you this sheet that you and Paul gave us yesterday, the one that Paul has testified is in Pete's handwriting. Do you recognize that as Pete Rose's handwriting.

MARCUM:

Yeah.

DOWD:

The numbers and the letters?

MARCUM:

Yes, like the "w's" and the "l's" only because I would watch him when we would sit at his house, I would watch him open this book and write them so I knew...I would say yes...I knew.

DOWD:

Okay. Let me ask you both, it is a personal question and please take it in the spirit that it is asked. As you well know, the people we report to have to make a very, very serious decision, it is important to them that they know as much about you as they can. I need to know whether either of you in talking to us either today or yesterday are on any medication, drugs or alcohol.

MARCUM:

No.

JANSZEN: No.

DOWD: Now, Paul you have already answered so I won't ask you again, but Danita I would like to ask you have you ever been addicted to either alcohol, drugs or are you taking any drugs, or do you have any problems

with that?

MARCUM: No.

DOWD: You look very healthy to me.

MARCUM: I have never done cocaine, never tried it. Alcohol, just a special occasion, we'll have a couple of .drinks, you know other than that, very, very rare. I am not addicted to anything.

DOWD: Danita, let me ask you, if you were asked to step into the well of a U.S. District Court raise your right hand, would you swear that the information that you have given us with Paul the last couple days is true?

MARCUM: Yes.

DOWD: Okay. I would like to ask Paul whether you would submit to a polygraph examination on some very simple, but very key questions.

JANSZEN: I certainly would.

DOWD: And, Danita would you do the same.

MARCUM: Yes, I would.

DOWD: Again, I hope you are not offended by those questions.

JANSZEN: Not at all.

DOWD; Those are questions that the Commissioner and the new Commissioner and the Deputy Commissioner are all very smart, honorable and serious men who have loved the game all their lives and they know that Pete Rose is a hero, he is loved by children and adults throughout America, but they have no fear about making a correct decision and it is our responsibility to report candidly to them and give our candid advice which we will do and we have no fear of doing so.

JANSZEN: Well, I have no fear of doing the same thing either.

And, if you would not have brought that up I would

have suggested that to you to take back to New York with you.

DOWD:

Okay. I need to know how we can get in touch with you probably through Joe who is in Cincinnati and Kevin and I may want to come out again. There are always loose ends as you know from dealing with FBI agents, questions occur to you, we read over our notes and our transcripts, etc., and we may want to visit with you and let you read what we have recorded I don't expect, I have never expected any witness that I have ever talked to and I am sure Kevin has talked to thousands like I have over the years, to be perfect. And, you are not perfect you are human, mistakes can be made and it may be I think worthwhile to consider that Kevin is getting these things typed up. My secretary is working on the tapes we had yesterday. You know, we are going to have questions both large and small and we want to get back to you, probably want to arrange for a polygraph operator. I need to have some sense of your schedule, where we can locate you, sometimes we can lose some time in setting things up, sometimes we need to get you quickly, at all times respecting your privacy and your convenience, we don't want to

disrupt your life, but on the other hand we may be pressed to arrange some things and we certainly want to be very considerate and accommodating in setting that up. So, I really, I bet Joe and I had to fish around a little bit to find you today.
