Dear Roger:

This letter will confirm our telephone conversation yesterday concerning the various outstanding items that the Commissioner needs from Mr. Rose.

It is my understanding that you will speak to Mr. Rose about his waiving any objection to my listening to a taped conversation between Paul Janszen and Michael Bertolini in which Mr. Rose is mentioned. If you do not object, kindly send me a letter confirming the waiver.

We need to know as soon as possible when we can pick up and copy the outstanding documents that I have previously requested, including the Customs files concerning Mr. Rose.

At the present time, Mr. Bertolini and his lawyer have declined to produced the records of Sports Images, Inc. and Hit King Marketing, Inc. Mr. Gallen intends to report to me next week on the status of Mr. Bertolini's cooperation. In the meantime, I would request that Mr. Rose seek from the Star Bank, also known as the First National Bank, copies of all of the account records, checks, deposit slips, loans and notes pertaining to Sports Images, Inc. and Hit King Marketing, Inc. I have been advised by Mr. Bertolini that Mr. Rose is the signatory on those accounts and that Mr. Rose co-signed the notes for the various loans that were made to those enterprises.
