On March 8, 1989, Paul Janszen was interviewed by Kevin M. Hallinan and Joseph R. Daly in Cincinnati, Ohio. Janszen furnished the following names, phone numbers and information, based upon a review of his address book during the interview:

Janszen said that Arnie Metz formerly worked for the Cincinnati Reds in general maintenance and was let go about a year ago. Metz and Rose have known each other for about ten years. Metz's former wife, Darlene, works in concessions at the race tracks and she hates Arnie. When Darlene and Arnie were married, Rose handled the wedding arrangements.

Based upon talk among the race track people he believes Rose was a winner in the "Pic Six" race at Turfway about two months ago. Rose would normally bet \$2,000 to \$4,000 tickets at the track. Metz cashed winning tickets for Rose in the past and if Rose won a large amount like the Pic Six, Metz would have cashed the ticket for Rose.

In January, 1987, Tommy Gioiosa and Arnie Metz were with Janszen at Turfway and Rose shows up. On this day the Pic Six was worth a lot of money. Janszen and Rose bought a ticket for \$2,000, with Rose putting up \$1,500 and Janszen, \$500. Janszen then sold Gioiosa half of his \$500 share for \$250. The ticket won and paid \$40,000. Rose's share was \$30,000 and Janszen and Gioiosa split \$10,000. Gioiosa cashed the ticket so he would be shown as the winner for tax purposes even though most of the winnings belonged to Rose.

Janszen said that Rose Fernbach was a former girlfriend of Tommy Gioiosa and she was about seventeen at the time. Gioiosa treated her badly. She became pregnant by Gioiosa and he convinced her to get an abortion. She married (not Gioiosa) about two months ago and is believed to be in Atlanta.

The present owner of Gold's Gym in Cincinnati is Joe Mansour, an accountant. Mansour is involved in selling steroids.

Janszen was asked if he bet on the same baseball teams to win as Rose did. He said he bet just the opposite of Rose as Rose was terrible in picking winners. He said Rose would get into too many minor variables in determining who Rose believed would win games.
