On April 27, 1989, Paul Janszen was interviewed at the Cincinnati BRI office by Kevin M. Hallinan and BRI Investigator Joseph E. Daly.

Janszen was shown the attached document (marked A) which has written on it, days of the week, dates, and numbers. Ron Peters previously identified this document as a reconciliation of Pete Rose's betting with Peters in 1987 which was given to Peters by Paul Janszen.

Janszen was asked if he recognized the document. He looked at it for several seconds and said he didn't recognize it and he asked what it was. He was told the interviewer had been told the document could have been prepared by him (Janszen) and was a reconciliation of his betting with Ron Peters.

Janszen then studied the document, wrote the days of the week on a piece of paper (attached, marked B) and said the document was in his handwriting but he didn't remember giving it to Peters. He continued to study the document and said the document included a compilation of the amount Ron Peters owed Pete Rose and Janszen for betting in 1987. Janszen said the figures at the top of the page that end with "Tuesday, July 14" are for the time period when Janszen was placing bets with Peters for Pete Rose. Janszen said that July 14 was definitely the last day Rose bet with Peters through Janszen.

Janszen reviewed seven daily betting slips dated July 24, 25, 26, 27, 28, 29, and August 1, (as identified by Peters and attached, marked C) and Janszen said the bets for 5 (\$500) could be his as that was the amount he always bet and the 15 and 25 (\$1500 and \$2500) bets could be someone else's \$1,000 or \$2,000 bets, plus or minus his (Janszen's) \$500 bets. Janszen then added that, even though the betting on the days after July 14 was the same pattern as the betting he did for Pete Rose (with Rose betting the \$1000 and \$2000 amounts according to Janszen) and himself, he doesn't remember Rose betting through him (Janszen) at all after July 14.

Janszen said he remembers Mike Bertolini bet like Rose and perhaps Janszen was calling in bets to Peters for Bertolini after July 14, but he cannot specifically remember this and it is only a "gut feeling". Janszen said he just can't remember betting after the 1987 All Star break.

Janszen said Bertolini is the only person besides Rose who he can remember betting large amounts.

It was pointed out to Janszen that there were no bets on the Cincinnati Reds on the betting slips he was shown and Janszen was asked if this could "jog" his memory. Janszen advised it didn't. Janszen said Mike Bertolini would bet on the same teams as Rose, as Bertolini would say "who does Pete like?" when deciding how to bet.

Janszen said the - 3900 figure with GIO written beside it is \$3,900 Tommy Gioiosa owed Ron Peters for bets Gioiosa placed for Bertolini and Janszen. Janszen said Bertolini had lost three \$1,000 basketball bets plus \$300 vigorish and Janszen had lost \$600 on football and basketball. Janszen said this \$3,900 was paid to Gioiosa by Janszen's brother, Pat, and Gioiosa never paid Peters. This was part of the \$34,000 check from Rose to Gioiosa that Rose wrote to pay Peters but Gioiosa kept. Gioiosa said said he would "take care" of the \$3,900 owed to Peters.

Janszen said the "approximately" amounts written on document A are probably bets he gave to someone taking bets for Peters and Janszen didn't get the exact amounts won or lost.

Janszen said Peters sister, Sherry, took some bets from Janszen for Peters. He said "Chuck" also took bets for Peters.

Janszen said Tammy Apple was Mike Bertolini's girlfriend in 1987 and would know about Bertolini's activities. Bertolini lived at One Lytle Place in 1987.
